ORDER

The State of California, Department of Public Works, is authorized to construct State Route IV-SCL-68-A (Bypass U.S. 101) at separated grades over the spur track of Southern Pacific Company at Moffett Field, Santa Clara County, at the location as shown by map (Exhibit "B") attached to the application, to be identified as Crossing No. E-38.29-AC.

Applicant, also, is authorized to construct the following crossings at grade over said spur track:

Jidth of the crossings and the grades of the approaches shall be as shown in the application. Construction of the crossings at grade shall be equal or superior to Standard No. 2 of General Order No. 72.

Construction and maintenance expense shall be borne in accordance with an agreement to be entered into between the parties relative thereto, and copy of said agreement, together with plans of said crossings apyroved by Southern Pacific Company, shall be filed with the Commission within 180 days from the date hereof. Should the parties fail to agree, the Commission will apportion the cost of construction and maintenance by further order. Clearances shall conform to the provisions of General Order No. 26-D. Upon completion, Crossing No. 2-38.27-C located about 500 feet easterly of the proposed overhead structures shall be abandened and closed.

Within thirty days after completion pursuant to this order applicant shall so advise the Commission in writing. This authorization shall expire if not exercised within three years unless time be extended or if conditions are not complied with. The effective date of this order shall be twenty days after the date hereof.
