OPINION AND ORDER

By Decision No.59599, dated February 1, 1960, in Case No. 5432, the rates, rules and charges named in Minimum Rate Tariff No. 2 pertaining to the transportation of lumber and forest products were revised. By this petition, filed March 24, 1960, the California Trucking Associations, Inc., seeks reductions in certain of the rates named in Item No. 710, pertaining to transportation in southern California.

Petitioner states that it is informed and believes that the changes it proposes in the rates subject to a minimum weight of 40,000 pounds are necessary to reflect current competitive factors and to provide an orderly relationship between such rates and other rates in the tariff applying on the same commodities. The petition atso states that the proposed revision is urgently needed to prevent unnecessary disruption of distribution and marketing practices and is desired by, and will be in the interest of, both carriers and shippers.

A copy of the petition was served on interested parties. No one objects to the granting of the petition. In the circumstances

it appears and the Commission finds, that petitioner's proposed revisions of Item No. 710 of Minimum Rate Tariff No. 2 are reasonable. The petition will be granted. A public hearing is not necessary.

> Therefore, good cause appearing, IT IS ORDERED:

1. That Minimum Rate Tariff No. 2 (Appendix "D" of Decision No. 31606, as amended) is hereby further amended by incorporating therein to become effective July 22, 1960, Fourth Revised Page 56-B, which revised page is attached hereto and by this reference made a part hereof.

2. That tariff publications authorized to be made by common carriers as a result of the order herein may be filed not carlier than the effective date hereof, and may be made effective on not less than five days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order.

3. That common carriers be and they are authorized to depart from the provisions of Article XII, Section 21, of the Constitution, and Section 460 of the Public Utilities Code, to the extent necessary to adjust long-and-short-haul departures now maintained under outstanding authorizations; that such outstanding authorizations be and they are hereby modified only to the extent necessary to comply with this order; and that schedules containing the rates published under this authority shall make reference to the prior orders authorizing long-and-short-haul departures and to this order.
