## OPINION AND ORDER

Edward G. Heck, an individual doing business as Santa Rosa Delivery Service, operates a local delivery service in Sonoma County as a radial highway common carrier and city carrier.

By Decision No. 57294, dated September 2, 1958, in
Case No. 5432 (Petition for Modification No. 113), Edward G. Heck
and Duke G. Carner, a partnership doing business as Santa Rosa
Delivery Service, were granted an exemption from the established
minimum rates set forth in Minimum Rate Tariff No. 2 for the
transportation of packages weighing 100 pounds or less delivered from
auto parts wholesalers, film finishers and wholesale pharmaceutical
houses; and for the transportation of documents and miscellaneous
papers, weighing 100 pounds or less, delivered to and from banks,
savings and loan institutions, title companies and radio stations;
all within a radius of twenty-five miles of Santa Rosa.

This decision amended Decision No. 52199, dated November 7, 1955, in Case No. 5432, by adding thereto the present exemption in the name of the partnership. Effective March 21, 1960, the permits originally issued to the partners were transferred to Edward G. Heck, who is now the sole owner of the business.

By this petition, filed April 25, 1960, Edward G. Heck seeks an order authorizing the same exemption in his own name as that previously granted to the partnership. The verified petition shows that, on or about April 22, 1960, a copy thereof was served on the California Trucking Associations, Inc., and United Parcel Service. No objection to its being granted has been received.

It appears, and the Commission finds, that the continuation of the present exemption in the name of Edward G. Heck by the substitution of his name in place of the partnership, now dissolved, is justified. The petition will be granted. A public hearing is not necessary.

Therefore, good cause appearing, IT IS ORDERED:

as amended, is hereby further amended by substituting in the list of carriers in Appendix "B" thereof, the name of Edward G. Heck, an individual doing business as Santa Rosa Delivery Service, in the place and stead of Edward G. Heck and Duke G. Carner, doing business as Santa Rosa Delivery Service, for the transportation of shipments weighing 100 pounds or less, within a radius of 25 miles of Santa Rosa, (a) delivered from auto parts wholesalers, film finishers and wholesale pharmaceutical houses; and (b) consisting of documents and miscellameous papers delivered to and from banks, savings and loan institutions, title companies and radio stations.

(2) That the authority granted to Edward G. Heck and Duke G. Carner, a partnership doing business as Santa Rosa Delivery Service, by Decision No. 57294, dated September 2, 1958, in Case No. 5432 (Petition for Modification No. 113), is hereby canceled and superseded by the authority granted herein.

This order shall become effective twenty days after the date hereof.
