Petition of Baker's Transfer & Storage, Bekins Van Lines, Inc., C. A. Buck Moving & Storage Company, Calmay Van Lines, Inc., W. Ray James, doing business as James Van Lines, Western Van & Storage Company, doing business as Liberty Van Lines, and Lyon Van Lines, Inc., to suspend certi-ficates of public convenience and necessity or tariffs covering the transportation of used household goods and malated antiples Application No. 38454 used household goods and related articles. Application of United California Express & Storage Co., to suspend certificate of Application No. 38780 public convenience and necessity. Investigation on the Commission's own motion into highway common carrier operating rights for the transportation Case No. 5854 of used household goods and personal effects, office, store and institution furniture and fixtures.

ORDER REVOKING OPERATIVE RIGHTS

Calmay Van Lines, Inc., possesses a certificate as a highway common carrier for the transportation of used household goods and personal effects and related articles. Subsequent to the enactment of the Eousehold Goods Carriers' Act, upon the application of this carrier, the Commission suspended the operation of its highway common carrier certificate (Decision No. 55020, dated May 21, 1957, in Applications Nos. 38454 and 38780, 55 Cal.P.U.C. 607).

By letter dated July 26, 1960, Calmay Van Lines, Inc., through its attorney, now requests that the suspension be made permanent or that its certificate of public convenience and necessity and tariffs be revoked.

In the circumstances, the certificate of public convenience and necessity will be revoked, and the tariffs canceled.

Therefore, good cause appearing,

IT IS ORDERED:

(1))That the certificate of public convenience and necessity acquired by Calmay Van Lines, Inc., by Decision No. 40898, dated November 4, 1947, in Application No. 28802, is hereby revoked.

(2) That T.A.L. Loretz, Agent, is authorized and directed to cancel the participation of Calmay Van Lines, Inc., from his tariffs on file with this Commission, for the transportation of used household goods and personal effects and related articles, said cancellation to be made within 90 days after the effective date of this order, and on not less than five days' notice to the Commission and to the public.

The Secretary is directed to cause personal service of a cortified copy of this order to be made upon Calmay Van Lines, Inc., and to mail a copy of this order to T.A.L. Loretz, Agent.

The effective date of this order shall be the twentieth day after service thereof upon Calmay Van Lines, Inc., unless before such effective date there shall have been filed with this Commission a written response to this order denying the facts set forth herein, or requesting public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
