OPINION AND ORDER

The applicant is operating as a highway common carrier under a certificate of public convenience and necessity granted by Decision No. 53584, dated August 7, 1956, as amended by Decision No. 54095, dated November 19, 1956, in Application No. 36055, which authorizes the transportation of whey and skim milk, ice, buttermilk, milk products, and milk cans over a portion of Central California.

Applicant now requests that its certificate of public convenience and necessity be amended by deleting the following commodities from the list of commodities permitted to be transported:

> "Buttermilk, liquid, butterfat or cream, liquid, and milk, liquid, when shipped in milk shipping cans, in bottles, in cases or crates, or in bulk in tanks."

As a justification for the deletion requested, the applicant has alleged that the commodities enumerated are not rated under Minimum Rate Tariff No. 2 and are normally transported by contract carriers who do not file rates for the movement of milk, butterfat or cream. This has enabled several permitted carriers to operate at rates lower than those set out in applicant's tariff, thereby causing the applicant to lose customers and suffer a financial loss. The applicant alleges that it cannot compete with permitted carriers on the items listed unless the said items are eliminated from applicant's certificate and tariffs.

Decision No. 55820, dated November 12, 1957, in Application No. 39492, transferred all operative rights, business and assets from Manuel Souza, doing business as Souza's Milk Transportation, to Souza's Milk Transportation Co., a California corporation.

The Commission having considered the matter hereby finds that the granting of the deletion requested in this application would not be adverse to the public interest. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS ORDERED that:

1. Appendix A to Decision No. 53584 dated August 7, 1956, as amended by Decision No. 54095 dated November 19, 1956, in Application No. 36055, be and it is further amended by substituting Second Revised Page 1 and First Revised Page 2 in place and stead of First Revised Page 1 and Original Page 2.

2. Decision No. 54095 is further amended by substituting Souza's Milk Transportation Co., for Manuel Souza, wherever the latter name appears in the said decision, or in the appendix attached thereto.

3. Decision No. 53584, as amended by Decision No. 54095 and as further amended herein, is continued in full force and effect.

4. Within sixty days after the effective date hereof, and on not less than ten days' notice to the Commission and to

the public, applicant shall amend its tariffs on file with this Commission to reflect the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.
