In all other respects Decision No. 59054 shall remain in full force and effect.

Conditions and Restrictions

- a. Service shall be rendered only between points of service hereinabove set forth, on the one hand, and the Pasadena Rose Bowl and Parade Area, on the other hand.
- b. Service shall be limited to the transportation of passengers on the basis of a round trip fare only.
- c. Service shall be rendered on New Year's Day (or such day of each year as the Rose Bowl Game and Parade may be held if conditions require postponement) only.

Routes

Applicant shall operate over and along the most appropriate and direct route or routes, subject to local traffic rules.
