<u>O P I N I O N</u>

By this application filed July 19, 1960, Lucille Princeau, doing business as Airline Cab and Limousine Company, requests permission to discontinue the service of transporting passengers and their baggage between Salinas Municipal Airport and Monterey Peninsula points.

As justification for her request she alleges that there has been no need for this service since January 6, 1956, when United Airlines was authorized to provide air service directly to the Monterey Airport. Evidently there have been no airline passengers carried since said date. The Commission staff after a study of applicant's operation recommends granting this application without holding a public hearing.

After consideration the Commission is of the opinion and finds that public convenience and necessity no longer require a continuation of applicant's service so far as it involves the Salinas Airport. A public hearing is not necessary.

O R D E R

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED:

1. That applicant is hereby authorized to discontinue passenger stage service between Salinas and Monterey Peninsula points.

2. That, within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and the public, applicant shall amend or reissue her tariffs and time schedules to reflect the authority herein granted.

3. In the place and stead of its existing operative authority a certificate of public convenience and necessity is hereby granted to Lucille Princeau, doing business as Airline Cab and Limousine Company, authorizing the transportation of passengers between the points and over the routes set forth in Appendix A attached hereto and by this reference made a part hereof.

4. The operative authority granted in Decision No.50019 in Application No. 34253 is hereby revoked.

The effective date of this order shall be twenty days after the date hereof.

Lucille Princeau, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport passengers and their baggage arriving or departing on airplanes which are operated to or from the Montercy Peninsula Airport over and along the routes and within the area hereinbelow described subject, however, to the authority of this Commission to change or modify said route at any time, and subject to the following restriction:

> Applicant shall transport only passengers destined to or originating at the Monterey Peninsula Airport.

Route

Between Monterey Peninsula Airport on the one hand, and the Cities of Monterey, Carmel, Pacific Grove, Seaside, the Presidio of Monterey and points intermediate thereto, on the other hand.
