SUPPLEMENTAL OPINION AND ORDER

The Order Instituting Investigation and Determining Warehouse Operative Rights issued in this proceeding on August 1, 1960, determined the warehouse operative rights of C. E. Jenan, Alden Jenan, Vincent Jenan, and Mrs. J. L. Holman, doing business as Linda Loma Ranch, in accordance with the facts stated in a certified report filed by the company.

On September 8, 1960, the Commission received from C. E. Jenan a letter dated September 7, 1960, wherein it is stated that the warehouse floor space actually operated as a public utility on September 1, 1959, was 7,000 square feet, rather than 114,000 square feet stated in the certified report. The latest verified annual report of Linda Loma Ranch (for the year ending February 28, 1960) shows that the warehouse capacity is 7,000 square feet.

Appendix "A" of the Commission's order in this proceeding dated August 1, 1960, will be amended accordingly.

IT IS ORDERED:

(1) That the aforesaid letter dated September 7, 1960, is entered in this proceeding as Exhibit No. 2.

(2) That First Revised Appendix "A", which by this reference is made a part hereof, is substituted for Appendix "A" of the Commission's order dated August 1, 1960, in this proceeding.

The Secretary is directed to cause certified copies of

this order to be served forthwith upon the respondents in this proceeding.

The effective date of this order shall be twenty days after the date hereof.
