OPINION

Dan Thomas Costello requests a license to engage in business as a motor transportation broker at 290 Grand Avenue, Oakland, California.

Applicant has on file a surety bond as provided for in Section 4838 of the Public Utilities Code.

After consideration the Commission is of the opinion that the application should be granted. A public hearing is not necessary.

ORDER

Application having been filed, and the Commission being informed in the premises,

IT IS ORDERED that a license is hereby granted to Dan Thomas Costello to act as a motor transportation broker as defined in Section 4803 of the Public Utilities Code, subject to the conditions hereinbelow set forth:

(a) That the said licensee shall keep his license certificate as a motor transportation broker posted at his authorized place of business at 290 Grand Avenue, Oakland, California, in order that it is readily available to public inspection at all times.

- (b) That the said licensee shall do business as a motor transportation broker at the following location only, to wit: 290 Grand Avenue, Oakland, California; and for motor carriers for whom he may hereafter from time to time be permitted to do business by any subsequent Commission order, and all other names which may be included in this order by amendment effected by applicant's stating their names and addresses in one or more letters addressed to this Commission and duly deposited in the United States mail with appropriate stamps affixed thereto, such mailing to be completed prior to the performance of any transportation arranged by applicant.
- (c) That the said license shall authorize licensee to sell, offer for sale, negotiate for, furnish or provide transportation over the public highways of this State for Airway Trucking, 6220 So. Garfield Avenue, Bell Gardens, California; Constructors Transport Co., 1205 Date Street, Montebello, California; M & L Trucking Co., 1920 Second Street, Berkeley, California, and J. M. Boss Trucking, Oakdale, California.

The Secretary of the Public Utilities Commission shall issue and deliver to Dan Thomas Costello a license certificate as a motor transportation broker in the form heretofore adopted by the Commission for such license certificate and subject to the conditions hereinabove set forth, provided that the names of the motor carriers applicant is authorized to serve need not be set forth therein but in the space provided in said license certificate for such names there shall be stated the following:

"Licensee is authorized only to negotiate for or hold himself out as one who furnishes or provides transportation in interstate or intrastate commerce over the public highways as a motor transportation broker on behalf of the motor carriers included in the order of the Public Utilities Commission granting this license or subsequently included by amendment."

The effective date of this order shall be January 1,
