### OPINION

20th Century Trucking Company, presently rendering service as a highway common carrier between points within the Los Angeles Basin Territory, requests authority to extend service to the San Diego Territory and all intermediate points along and within five miles laterally of U. S. Highways Nos. 101 and 101 Alternate.

A public hearing was held before Examiner Thomas E. Daly on October 18, 1960, at Los Angeles and the matter was submitted. No appearance was made in protest to the authority sought.

Applicant is currently certificated by Decision No. 54367 dated January 8, 1957, in Application No. 36286. In addition to its certificated authority applicant holds permits as a city carrier and as a radial highway common carrier. Applicant owns and operates 111 pieces of equipment and maintains terminal and office space in Los Angeles. If the authority sought is granted a terminal will be established in San Diego. As of August 31, 1960, applicant indicated a net worth in the amount of \$51,492.73 and for the first eight months of 1960 realized a net profit in the amount of \$11,390.98, before provision for income taxes.

At the present time applicant serves approximately 625 accounts daily; shipments range from 1 pound to 10,000 pounds; pickup service is usually provided from 2:00 p.m. to 5:00 p.m., however, an earlier or later pickup service is provided upon request; a same day service is provided within a 25 mile radius of Los Angeles. A comparable service is proposed to the extended area.

It was stated that for the past two years applicant has conducted a survey relating to the proposed area. During this time 400 individuals were interviewed, 66 percent of whom were regular customers of applicant. According to applicant many of the shippers, because of limited dock space, wished to use a carrier with a wider territorial coverage. A number of applicant's customers assertedly requested applicant to make available the same service to the proposed area. Based upon the survey applicant estimates that it would receive approximately 4,000 shipments the first month of operation if the authority sought is granted. Applicant further estimates that the first month of operation would result in a gross revenue of \$20,000 with expenses estimated at approximately \$17,000.

Applicant was prepared to call 16 public witnesses, but in the absence of protest their names and the names of the companies represented were received as a late-filed exhibit. According to the exhibit these individuals represent companies engaged in large and diversified businesses, which ship regularly to points within the extended area.

Although applicant served an area north of Santa Monica prior to its certification, the area was not included in its presently certificated authority. Applicant has continued to serve the area, which includes San Fernando, Chatsworth and Woodland Hills, as a

A. 42228 ET permitted carrier. It is requested that the area be included within applicant's certificate. After consideration the Commission finds and concludes that public convenience and necessity require the granting of the authority sought. <u>ORDER</u>

Application having been filed and the Commission being informed in the premises,

#### IT IS ORDERED:

- 1. That a certificate of public convenience and necessity is hereby granted 20th Century Trucking Company authorizing the transportation of property between the points and over the routes set forth in Appendices A, B and C attached hereto.
- 2. That in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
  - Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 99 and insurance requirements of the Commission's General Order No. 100-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 99 and 100-A, may result in a cancellation of the operating authority granted by this decision.
  - b. Within one hundred twenty days after the effective date hereof, and on not less than ten days' notice to the Commission and the

public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs, satisfactory to the Commission.

(3) That the certificate of public convenience and necessity granted in paragraph 1 of this order is in lieu of and supersedes the certificate of public convenience and necessity granted by Decision No. 54367 dated January 8, 1957, in Application No. 36286, which certificate is hereby canceled and revoked, said revocation to become effective concurrently with the effective date of the tariff filings required by paragraph (2)b hereof.

The effective date of this order shall be twenty days after the date hereof.

#### CONDITIONS:

Applicant shall not transport the following commodities:

- 1. Used household goods and personal effects not packed in accordance with the crated property requirements set forth in paragraph (d) of Item No. 10-C of Minimum Rate Tariff No. 4-A.
- 2. Automobiles, trucks and buses, viz., new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- Livestock; viz., bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags, or swine.
- Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerator equipment.
- 5. Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles.
- 6. Commodities when transported in bulk in dump trucks or in hopper-type trucks.
- Commodities when transported in motor vehicles equipped for mechanical mixing in transit.
- 8. Logs.
