<u>O P I N I O N</u>

Coast Line Truck Service, Inc., requests authority to sell and Southern California Freight Lines, Inc., requests authority to purchase certain highway common carrier operative rights.

Both applicants are wholly owned subsidiaries of Southern California Freight Lines, Ltd. Although each applicant may transport general commodities as a matter of policy, customers have been encouraged to use Seller for shipments of produce and Buyer for shipments of dry freight. To avoid confusion and to reduce tariff publication costs it is the desire to have applicant Seller transfer its general commodity authority and to retain its produce authority. The agreed cash consideration is \$500.

After consideration, the Commission finds and concludes that the proposed transfer would not be adverse to the public interest. A public hearing is not necessary.

For the purpose of clarifying the Commission's records, new certificates will be issued covering the rights involved herein.

ORDER

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED:

1. That on or before April 1, 1961, Coast Line Truck Service, Inc., may sell and transfer, and Southern California Freight Lines, Inc., may purchase and acquire, all highway common carrier operations currently conducted by Coast Line Truck Service, Inc., except operations for the transportation of fresh or green fruits and vegetables, berries and mushrooms, as granted by Decisions Nos. 50152, 50500, 52057 and 53876.

2. That within thirty days after the consummation of the transfer herein authorized, applicants shall notify the Commission in writing of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. That on not less than five days' notice to the Commission and to the public, effective concurrently with the consummation of such transfer, applicants shall amend or reissue the tariffs on file with the Commission, naming rates, rules and regulations governing the operations herein involved to show that Coast Line Truck Service, Inc., has withdrawn or canceled, and Southern California Freight Lines, Inc., has adopted or established as its own, said rates, rules and regulations. The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80.

4. That effective concurrently with the effective date of tariff filings required by paragraph 3 hereof, any and all certificates of public convenience and necessity currently held by Coast Line Truck Service, Inc., are hereby revoked and canceled, and simultaneously therewith, an in-lieu certificate of public convenience and necessity is hereby granted to Coast Line Truck Service, Inc., authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points and over the routes as more particularly set forth in Appendix A, attached hereto and made a part hereof.

5. That effective concurrently with the effective date of tariff filings required by paragraph 3 hereof, a certificate of public convenience and necessity is hereby granted to Southern California Freight Lines, Inc., authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points and over the routes as more particularly set forth in Appendices A, B, C and D, attached hereto and made a part hereof.

6. That in providing service pursuant to the certificates granted in paragraphs 4 and 5 hereof, applicants shall comply with and observe the following service regulations:

> (a) Within thirty days after the effective date hereof, applicants shall file written acceptances of the certificates herein granted. By accepting the certificates of public convenience and necessity herein granted, applicants are placed on notice that they will be required, among other things, to file annual reports of their operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 99

and insurance requirements of the Commission's General Order No. 100-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 99 and 100-A, may result in a cancellation of the operating authority granted by this decision.

(b) That on or before April 1, 1961, and on not less than five days' notice to the Commission and to the public, applicants shall establish the service herein authorized and file in triplicate, and make effective, concurrently with the consummation of the transfer herein authorized, tariffs satisfactory to the Commission.

The effective date of this order shall be twenty days

after the date hereof.

Territories in the vicinity of Salinas are described as follows:

- (1) Beginning at the intersection of the San Juan Grade Road and the northeasterly boundary of Monterey County, thence southwesterly along said road to its intersection with U.S. Highway 101 approximately 3 miles north of Salinas, thence along U.S. Eighway 101 to the City of Salinas, thence along the Salinas-Monterey Highway to its intersection with the Marina-Hilltown Road, including all points within three miles laterally of the hereinabove described routes.
- (2) Beginning at a point formed by the intersection of U.S. Highway 101 with the Salinas-Watsonville Highway in the City of Salinas, thence northwesterly along said Salinas-Watsonville Highway to a point formed by the intersection of said Salinas-Watsonville Highway with Dolan Road just north of Moss Landing, including all points on all highways in the territory for a distance of three miles laterally of the hereinabovedescribed routes.
