## <u>O P I N I O N</u>

Charles L. Long requests a license to engage in business as a motor transportation broker at 746 South Central Avenue, Los Angeles 21, California.

Applicant has on file a surety bond as provided for in Section 4838 of the Public Utilities Code.

After consideration, the Commission is of the opinion that the application should be granted. A public hearing is not necessary.

## <u>ORDER</u>

Application having been filed, and the Commission being informed in the premises,

IT IS ORDERED that a license is hereby granted to Charles L. Long to act as a motor transportation broker as defined in Section 4803 of the Public Utilities Code, subject to the conditions hereinbelow set forth:

- (a) That the said licensee shall keep his license certificate as a motor transportation broker posted at his authorized place of business at 746 South Central Avenue, Los Angeles, California, in order that it is readily available to public inspection at all times.
- (b) That the said licensee shall do business as a motor transportation broker at the following location only, to wit: 746 South Central Avenue, Los Angeles, California, and for motor carriers for whom he may hereafter from time to time be permitted to do business by any subsequent Commission order, and all other names which may be included in this order by

amendment effected by applicant's stating their names and addresses in one or more letters addressed to this Commission and duly deposited in the United States mail with appropriate stamps affixed thereto, such mailing to be completed prior to the performance of any transportation arranged by applicant.

The Secretary of the Public Utilities Commission shall issue and deliver to Charles L. Long a license certificate as a motor transportation broker in the form heretofore adopted by the Commission for such license certificate and subject to the conditions hereinabove set forth, provided that the names of the motor carriers applicant is authorized to serve need not be set forth therein, but in the space provided in said license certificate for such names there shall be stated the following:

> "Licensee is authorized only to negotiate for or hold himself out as one who furnishes or provides transportation in interstate commerce over the public highways as a motor transportation broker on behalf of the motor carriers included in the order of the Public Utilities Commission granting this license or subsequently included by amendment."
