SECOND SUPPLEMENTAL OPINION AND ORDER

Yerba Buena Water Company, a corporation, by Decision No. 59493, dated January 12, 1960; as modified by Decision No. 61403, dated January 24, 1961, was granted a certificate of public convenience and necessity to extend water service to a portion of Tract No. 1223, Ventura County, such authorization to become effective when the utility "...shall have satisfactorily demonstrated to this Commission that it has water production sources capable of safely yielding at least 78 gallons per minute of water acceptable in quality to the Department of Public Health."

Various letters and supporting documents received from the utility, including a copy of an amended Water Supply Permit issued January 26, 1961, indicate that the utility has obtained a water supply of acceptable quality in excess of the minimum yield required by Decision No. 59493; therefore,

IT IS HEREBY ORDERED that compliance by applicant with ordering paragraph (1) (a) of Decision No. 59493 is deemed to have been effected on January 26, 1961.

IT IS HEREBY FURTHER ORDERED that:

- 1. a. Applicant be and it is authorized to apply its presently filed rates and rules to the area certificated by Decision No. 59493 as modified by Decision No. 61403.
- b. Applicant is authorized and directed to revise, within thirty days after the effective date of this order, in conformity with General Order No. 96 and in a form acceptable to this Commission, such of its tariff schedules, including tariff service area maps, as are necessary to provide for the application of its tariff schedules to the area certificated by Decision No. 59493 as modified by Decision No. 61403. Such revised tariff sheets shall become effective upon five days' notice to the public and this Commission after filing as hereinabove provided.
- 2. Applicant shall file, within sixty days after the effective date of this order, four copies of a comprehensive map drawn to an indicated scale not smaller than 400 feet to the inch, delineating by appropriate markings the various tracts of land and territory served; the principal water production, storage and distribution facilities; and the location of the various water

system properties of applicant in and relating to the area certificated by Decision No. 59493 as modified by Decision No. 61403.

In all other respects Decision No. 59493, as modified by Decision No. 61403, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
