In the Matter of the Application of SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, for Certificate that Public Convenience and Necessity require and will require the exercise by Applicant of the rights, privileges and franchise granted by Ordinance No. 34 of the City of Los Alamitos, County of Orange, State of California, in accordance with Franchise Ordinance No. 34 of said City.

<u>O P I N I O N</u>

Southern California Edison Company, in this proceeding, requests a certificate of public convenience and necessity to exercise the rights and privileges of a franchise granted by the City of Los Alamitos, California, permitting the installation, maintenance and use of an electric distribution and transmission system upon the streets of said city.

The franchise referred to, a copy of which is attached to the application and designated as Exhibit A, was granted by the city in accordance with the Franchise Act of 1937 and is of indeterminate duration. A fee is payable annually to the city equivalent to 2 percent of the gross receipts arising from the use, operation, or possession of the franchise, but not less than 1 percent of the gross annual receipts from sales of electricity within the limits of the city under said franchise.

The costs incurred by applicant in obtaining the franchise are stated to have been \$16.23, which amount does not include costs incident to this application.

Applicant has served electricity in and about the City of Los Alamitos without competition for many years. As of December 31, 1959 it served 1,168 electric customers within the city. No objection to the granting of the requested certificate has been received. A public hearing is not necessary.

After consideration it is found as a fact that public convenience and necessity require the exercise by applicant of the right, privilege and franchise granted to applicant by Ordinance No. 34, of the City of Los Alamitos, California.

The certificate of public convenience and necessity herein granted is subject to the following provisions of law:

- 1. That the Commission shall have no power to authorize the capitalization of the franchise involved herein or this certificate of public convenience and necessity or the right to own, operate or enjoy such franchise or certificate of public convenience and necessity in excess of the amount (exclusive of any tax or annual charge) actually paid to the State or to a political subdivision thereof as the consideration for the grant of such franchise, certificate of public convenience and necessity or right.
- 2. That the franchise involved herein shall never be given any value before any court or other public authority in any proceeding of any character in excess of the cost to the grantee of the necessary publication and any other sum paid by it to the municipality therefor at the time of the acquisition thereof.
