ORDER REVOKING OFERATIVE RIGHTS

The certificate of public convenience and necessity issued to H. P. Younglove, M. Y. Hungerford and A. N. Younglove Trust, doing business as Home Oil Company, has been suspended since August 20, 1960, for failure to have on file requisite evidence of liability insurance. The insurance has not been reinstated nor has the carrier been paying its quarterly fees or filing its quarterly reports. By letter dated August 15, 1960, the carrier informed the Commission that it has been trying to find a purchaser for the certificate and would like to have as much time as is permissible in which to dispose of it. As of March 25, 1961, a purchaser had not been secured.

It appears that the carrier has abandoned all highway common carrier operations under its certificate of public

convenience and necessity, and the Commission being of the opinion that such abandonment constitutes good cause for revocation of the certificate and cancellation of the tariffs applicable to services thereunder.

IT IS ORDERED:

(1) That the certificate of public convenience and necessity to operate as a petroleum irregular route carrier granted to H. P. Younglove, M. Y. Hungerford and A. N. Younglove Trust, doing business as Home Oil Company, by Decision No. 44382, dated June 20, 1950, in Application No. 31244, is hereby revoked.

(2) That Western Motor Tariff Bureau, Inc., Agent, is hereby authorized and directed to cancel the participation of H. P. Younglove, M. Y. Hungerford and A. N. Younglove Trust, doing business as Home Oil Company, from its tariffs on file with this Commission, said cancellation to be made within 90 days after the effective date of this order, and on not less than five days' notice to the Commission and the public.

(3) That Power of Attorney AF1 No. 2 issued by H. P. Younglove, M. Y. Hungerford and A. N. Younglove Trust, doing business as Home Oil Company, in favor of Western Motor Tariff Bureau, Inc., Agent, is hereby canceled.

The Secretary is directed to cause service of a certified copy of this order to be made upon H. P. Younglove, M. Y. Hungerford and A. M. Younglove Trust and to mail a copy of this order to Western Motor Tariff Bureau, Inc., Agent.

The effective date of this order shall be the thirtieth day after such service upon H. P. Younglove, M. Y. Hungerford or A. N. Younglove Trust, unless before such effective date there shall
