ORDER MODIFYING DECISION NO. 60871

By Decision No. 60871, issued October 11, 1960, applicants were directed, among other things, to install a 5,000-gallon storage tank in order to improve service. Action to accomplish such installation became complicated by the inability of applicants to obtain satisfactory rights of way. Further, after consultation with the State's Department of Public Health, applicants decided to chlorinate the system's supply. A restudy of system problems in the light of these circumstances has led applicants to seek modification of the original order. It is now proposed to make certain additions and betterments to the system which, among other things, will accomplish the intended end results by different means. In the main, the proposals of applicants appear to be reasonable and the Commission finds that Decision No. 60871, heretofore issued in this matter, should be modified so as to implement the new proposals. Public hearing in the matter is not necessary.

Good cause appearing therefor,

IT IS ORDERED that Decision No. 60871 is hereby modified by striking from Ordering Paragraph 2 thereof, the reference to paragraph c of Chapter 6 of Exhibit No. 2.

IT IS FURTHER ORDERED that said Decision No. 60871 is hereby modified by adding to the numbered Ordering Paragraphs thereof the following:

- "4. By not later than December 31, 1961, applicants shall have accomplished the following:
  - a. The installation and proper operation of suitable chlorinating facilities at the main reservoir so as to chlorinate all water entering said reservoir; and
  - b. The installation and proper operation of approximately 470 feet of 2-inch galvanized dipped steel pipe, along the County Road, from the main reservoir to connection with the existing service pipeline from Gunning Creek; and
  - c. Installation of an automatic 1½ hp. pump, with pressure tank, for the purpose of supplying the Bishop residence and other customers in the vicinity with chlorinated water; and
  - d. Rearrangement or removal of piping and/or connections as appropriate to carry out the above objectives.
- 5. Applicants shall report to this Commission in writing of progress respecting the above-ordered installations on or about June 30 and September 30, 1961 and of their compliance within ten days thereafter."

IT IS HEREBY FURTHER ORDERED that said Decision No. 60871, except as hereinabove modified, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
