Theresa Gotelli, Adolph Gotelli and Edward Gotelli, copartners doing business as N. A. Gotelli Trucking, by the certificate of public convenience and necessity granted in the decision noted in the margin, are authorized to transport the following commodities:

- (a) FRUITS, FRESH (NOT COLD-PACK NOR FROZEN), OR VEGETABLES, FRESH OR GREEN (NOT COLD-PACK NOR FROZEN), as described under that heading in Items 41815 through 42220 (See Note).
- (b) NUTS, EDIBLE, as described under that heading in Items 70970 through 71090 (See Note).
- (c) Vegetable dinner ingredients, as described in Item 41030 (See Note).
- (d) Vegetable plants, noibn, as described in Item 70940 (See Note).
 - NOTE: The term "Items" as used above refers to the specified items published in Western Classification 76, J. P. Hackler, Tariff Publishing Officer, on the issue date thereof.

between:

- (1) All points and places on and within twenty miles laterally of U.S. Highway 99 between Sacramento and Los Angeles, inclusive.
- (2) Camarillo, Santa Paula, Oxnard and Fillmore, on the one hand, and Stockton and Sacramento, on the other hand.
- (3) Linden and Lodi, on the one hand, and Oakland, Sunnyvale, San Jose and Santa Clara, on the other hand.

The authorities set forth in Paragraphs Nos. (2) and (3) above do not include the right to render service to, from or between intermediate points.

THERESA GOTELLI, ADOLPH COTELLI and EDWARD GOTELLI First Revised Page 2 Cancels Original Page 2

The authority contained herein does not apply when:

- (a) The point of destination of the shipment is a cannery, accumulation station, cold storage plant, precooling plant, winery, or
- (b) When transported from the field or point of growth to a packing plant, or a packing shed (see Exception).
 - Exception: Except for the transportation of citrus fruits in field boxes or in bulk, or avocados, the provisions of paragraph (b) will not apply when the distance between point of origin and point of destination exceeds 50 constructive miles.
- (c) Sugar beets, when the point of destination of the shipment is a sugar beet factory or a railroad load-ing dump.
