FIRST SUPPLEMENTAL OPINION

The Commission by Decision No. 61168 dated December 13, 1960, in the above-numbered application granted to San Jose City Lines, Inc. a certificate of public convenience and necessity to provide passenger stage service within and around the City of Santa Clara in accordance with an agreement between the city and applicant for a period of six months.

By letter dated May 31, 1961, San Jose City Lines, Inc. advises that the above-mentioned six-month period will expire June 15, 1961, and that the City of Santa Clara has requested applicant to continue the authorized service on a reduced basis for at least one month beyond the expiration date, in order to afford the city an opportunity to make further studies of the future need for this service.

San Jose City Lines states that it is willing to continue this service as requested by the city and asks that a part of Route No. 8A, which duplicates a portion of applicant's Route No. 1, be discontinued in accord with the city's request.

After consideration the Commission finds and concludes that public convenience and necessity will not be adversely affected by the requested discontinuance of a portion of Route No. 8A. A public hearing is not necessary.
