ORDER REVOKING OPERATIVE RIGHTS

The certificate of public convenience and necessity issued to Handy Motor Lines, Inc., has been suspended since April 11, 1961, for failure to have on file requisite evidence of liability insurance.<sup>1</sup> The insurance has not been reinstated nor has the carrier been paying its quarterly fees nor filing its quarterly reports. Also, it does not have a freight classification on file with this Commission.

The Commission has received cancellation notices dated March 1, 1961, from Western Motor Tariff Bureau, Inc., Agent, and May 24, 1961, from Interstate Freight Carriers Conference, Inc., Agent, notifying the above-named carrier that its participation in

various tariffs would be canceled effective June 10 and August 28, 1961, respectively.<sup>2</sup>

By letters from the Secretary of the Commission dated March 8 and June 5, 1961, this carrier was placed on notice that its highway common carrier operative rights would be subject to suspension or revocation, pursuant to lawful procedures, unless new tariffs were filed and made effective concurrently with the scheduled cancellations. On May 8 and June 5, 1961, Western Motor Tariff Bureau, Inc., Agent, and Interstate Freight Carriers Conference, Inc., Agent, respectively filed with this Commission revised tariff pages eliminating Handy Motor Lines, Inc., as a participating carrier in their aforementioned tariffs effective on the dates hereinbefore mentioned. The carrier has not filed tariffs to replace the canceled tariffs.

Handy Motor Lines, Inc., having failed to have on file evidence of liability insurance, having failed to maintain tariffs in effect, and the Commission being of the opinion and finding that such failures constitute good cause for revocation of the certificate,

IT IS ORDERED that:

(1) The certificate of public convenience and necessity to operate as a highway common carrier acquired by Handy Motor Lines, Inc.,

a corporation, by Decision No. 59494, dated January 12, 1960, in Application No. 41447, is hereby revoked.


(2) Powers of attorney of Handy Motor Lines, Inc., are hereby canceled.


The Secretary is directed to cause service of a certified copy of this order to be made upon Handy Motor Lines, Inc., or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to Western Motor Tariff Bureau, Inc., Western Classification Committee, Interstate Freight Carriers Conference, Inc., and C. R. Nickerson.

The effective date of this order shall be the thirtieth day after such service upon Handy Motor Lines, Inc., or after the above mailing to Handy Motor Lines, Inc., as the case may be, unless before such effective date there shall have been filed with this Commission a written response to this order denying the facts set forth herein, or requesting public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
