# <u>O P I N I O N</u>

California Parlor Car Tours Company, presently engaged in the transportation of passengers and their baggage in sight-seeing and pleasure tours serving various points and places within the State of California requests the following:

- 1. Authority to discontinue service between Los Angeles and Pier "A" Docks, Los Angeles Harbor.
- 2. Authority to extend service to new points of interest such as Squaw Valley and Marineland.
- 3. The revision of certain routes so as to conform with recent highway and traffic changes.
- 4. The issuance of a new certificate restating its operative rights in a loose-leaf form.

It is alleged in justification of the relief sought that the service between Los Angeles and Los Angeles Harbor was authorized in 1934 for the purpose of receiving and discharging passengers in connection with trans-Pacific steamship service; that since 1934, probably due to the advent of air transportation, this patronage has declined and has now ceased; that during the period of 30 years which has elapsed since applicant first acquired its operating authority, there have been great changes within the areas applicant has been authorized to serve, particularly with respect to locations of highways and points of interest such as Squaw Valley and Marineland; and that certain revisions are made necessary because of changes in

the highways, in the one-way traffic regulations and in traffic conditions. It is further alleged that no other carriers are authorized to render the present or proposed service between San Francisco and Los Angeles, or between San Francisco and the Lake Tahoe area, or between San Francisco and Eureka.

After consideration the Commission finds and concludes that public convenience and necessity require the granting of the application. A public hearing is not deemed necessary.

# <u>order</u>

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED:

1. That a certificate of public convenience and necessity is hereby granted California Parlor Car Tours Company, a corporation, authorizing it to operate as a passenger stage corporation as defined in Section 226 of the Public Utilities Code between the points and over the routes more particularly set forth in Appendix A attached hereto and hereby made a part hereof.

2. That, in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

> a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98 and insurance requirements of the Commission's General Order No. 101-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 98 and 101-A, may result in a cancellation of the operating authority granted by this decision.

b. Within one hundred twenty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs, and time-tables, satisfactory to the Commission.

3. That the certificate of public convenience and necessity granted in paragraph 1 of this order supersedes the certificates of public convenience and necessity heretofore granted by the following decisions:

  - 1.09 From Monterey, over California Nighway 1 to Castroville, thence over California Nighway 156 to junction U. S. Highway 101 (Prumedale), thence over U. S. Highway 101 to Gilroy, thence over California Highway 152 to junction unnumbered highway (El Nido Junction), thence over unnumbered highway via El Nido to Merced, or from Prunedale over U. S. Nighway 101 to junction unnumbered highway west of San Juan, thence over unnumbered highway via San Juan and Hollister to junction), thence over route previously described to Merced.

1. Authority Limited to All-Expense Tours.

The sightseeing and pleasure tours herein authorized shall be operated only as "package" or "all-expense" tours wherein, in addition to the transportation to be provided, the company will, on receipt of advance payment therefor, arrange

for reservations for and the payment of the charges for required overnight accommodations, meals, and incidental expense in connection with the tours. Transportation which does not include such "package" or "all-expense" features is not authorized.

2. Deviation from Authorized Route.

Authority is granted to operate the authorized tours in visitation of points of interest -

(a) within incorporated municipalities located on authorized routes and

(b) by deviation from an authorized route not to exceed five air miles distant from such route.

3. Relocated Highways.

For the general operation of its system, on reconstruction or relocation of highways, the company may reroute its operations over such reconstructed or relocated highways, provided that it shall first advise the Commission, in writing, of said highway and route change, said notice to be accompanied by a sketch or map showing the highways involved.

SECTION II - GENERAL CONDITIONS (Contd.)

4. Authorization is for One-Way Service.

Unless otherwise specified in connection with the description of an authorized tour, the authority to operate such tour is for one-way service only, provided two one-way tours may be combined to constitute a round trip.

5. Service To Intermediate Points.

Authority is granted to serve only the named termini of the tours herein authorized. Authority is not granted to serve intermediate points on any of the tours herein authorized; provided, however,

(a) Passengers holding valid transportation for a complete tour may, on request, be received or discharged at an intermediate point on the tour, but without refund of the unused portion of the tour.

(b) The foregoing restriction shall not be so construed as to prevent the consolidation of separately authorized routes for purposes of operation.

5. (Contd.)

(c) Service is authorized to and from Merced for purposes of transfer of interline passengers destined to and from Yosemite National Park.

6. Filing of Time Schedules Not Required.

The tours herein authorized may be operated on demand at such times and with such frequency as traffic demands may from time to time require. The publication and filing of time schedules for such tours with the Commission will not be required.

7. Requirements for Advance Reservations.

With respect to any authorized tour, the company may require reservations to be made within sufficient time to enable the company to make proper provisions for hotel and other required reservations.

3. Minimum-Passenger Requirements.

(a) Tours may be operated with or without the privilege of exclusive occupancy of the passenger stage by the passengers of the tour as may be provided by appropriate tariffs to be filed with the Commission.

> (b) Tours operated under tariff provisions which do not provide for exclusive occupancy of the passenger stage by the group to be transported may be cancelled unless six or more adult tickets are presented for transportation on the tour.

(c) Tours operated under tariff provisions which provide for exclusive occupancy of the passenger stage by the group to be transported may be cancelled unless 20 or more adult tickets are presented for transportation on the tour.

9. Cancellation of Tour Due to Highway Conditions.

The operation of authorized tours is subject to cancellation by the company before commencement when in its opinion highway conditions are such that a portion of the tour may not be safely operated.
