In the Matter of the Application of UNION ICE & STORAGE COMPANY, a corporation, for authorization to discontinue cold storage warehouse operations at Firebaugh, California.

## OPINION

Union Ice & Storage Company requests authority to discontinue cold storage warehouse operations at Firebaugh, California.

It is alleged that applicant has been conducting cold storage warehouse operations at Firebaugh on a seasonal basis since 1951; that said warehouse comprises 8,000 square feet of space; that during the past three years applicant has been able to obtain only one storer at Firebaugh; that said storer has now removed all of its goods and the warehouse is empty; that the warehouse space is leased from applicant's parent company, The Union Ice Company, and that if the authority herein sought is granted the warehouse space will be surrendered to the parent company.

After consideration the Commission finds and concludes that the requested discontinuance of service would not be adverse to the public interest. A public hearing is not necessary.

## ORDER

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED:

1. That effective concurrently with the effective date of tariff filings referred to in paragraph 3 hereof, Union Ice &

Storage Company may discontinue cold storage warehouse operations in 8,000 square feet of space at Firebaugh.

- 2. That the operative rights as determined for Firebaugh by Order dated June 14, 1960, in Case No. 6533, as amended on July 26, 1960, are revoked, said revocation to be effective With the effective date of the tariff filings referred to in paragraph 3 hereof.
- 3. That applicant may amend its tariff on file with this Commission to show that the warehouse operations at Firebaugh have been discontinued, said tariff filings to be made on not less than ten days' notice to the Commission and to the public.
- 4. That effective concurrently with the effective date of tariff filings referred to in paragraph 3 hereof, Appendix A, attached hereto and by this reference made a part hereof, shall supersede the Appendix "A" attached to the order issued June 14, 1960, in Case No. 6533, as revised on July 26, 1960.
- 5. That the authority herein granted shall expire unless the tariff filing as herein authorized is filed with the Commission within one hundred twenty days after the effective date hereof.

The effective date of this order shall be twenty days after the date hereof.
