BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Application of THE GREYHOUND CORPORATION) for authority to conduct Special Operations) between Stockdale Junction and Stockdale, in Kern County.

Application No. 43608 (Filed July 18, 1961)

OPINION AND ORDER

The Greyhound Corporation requests authority to extend service to Stockdale located soutwest of Bakersfield, four miles west of U. S. Highway 99.

It is alleged that the Del Webb Company is developing housing for retired people at Stockdale; that applicant has received requests for transportation of groups of prospective purchasers, on the individual-fare basis, with times of departure from Los Angeles to be specified by the developer; that the passengers will be gathered together by the developer of the project through advertising which will include information on the availability of such transportation; and that since applicant is presently authorized to operate along U. S. Highway 99 between Los Angeles and Bakersfield the proposed extension will require certification between Stockdale Junction and Stockdale only.

After consideration the Commission finds and concludes that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary. Therefore,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to The Greyhound Corporation, authorizing the establishment and operation of service as a passenger stage corporation, as that

term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Fourth Revised Page 34-A, attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

- 2. Appendix A of Decision No. 55893 is hereby amended by incorporating Fourth Revised Page 34-A in revision of Third Revised Page 34-A.
- 3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:
 - a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
 - b. Within one hundred twenty days after the effective date hereof, and on not less than ten days' notice to the Commission and to the public, applicant shall establish the service herein authorized and file in triplicate, and concurrently make effective, tariffs and timetables satisfactory to the Commission.

The effective date of this order shall be twenty days after the date hereof.

APPENDIX A THE GREYHOUND CORPORATION

Fourth Revised Page 34-A Cancels Third Revised Page 34-A

13.17 - Between Lancaster and Mira Loma Facility:

From Lancaster, over California Highway No. 138 to Mira Loma Facility.

Scheduled service shall consist of at least one round trip each Sunday.

13.18 - Between Hollywood and Glendale:

From junction De Longpre Avenue and Vine Street, Hollywood, over Vine Street to Sunset Boulevard, thence over Sunset Boulevard to Western Avenue, thence over Western Avenue to Los Feliz Boulevard, thence over Los Feliz Boulevard to Brand Boulevard, Glendale, to be operated as an alternate route.

13.19 - Between Glendale and Pasadena:

From Glendale, over Brand Boulevard to junction California Highway 134, thence over California Highway 134 to Pasadena, to be operated as an alternate route.

13.20 - Between California City Junction and California City:

From junction U. S. Highway 6 and unnumbered highway north of Mojave (California City Junction), over unnumbered highway to California City.

Service is authorized to be conducted in Special Operations only.

No express shall be transported over this route.

*13.21 - Between Stockdale Junction and Stockdale:

From junction U. S. Highway 99 and Brundage Lane at the City Limits of Bakersfield (Stockdale Junction), over Brundage Lane and Stockdale Highway to Stockdale.

Service is authorized to be conducted in Special Operations only.

No express shall be transported over this route.
