ORDER SUSPENDING OPERATIVE RIGHTS

Carl P. Kreifels, doing business as Geneva Transfer & Drayage Co., possesses a certificate of public convenience and necessity to operate as a highway common carrier for the transportation of various commodities requiring refrigeration and empty containers between San Francisco and South San Francisco, on the one hand, and various central California points, on the other hand.

The Commission received a cancellation notice dated May 5, 1961, addressed to Kreifels whereby Western Classification Committee, Agent, notified him that his participation in Western Classification 77 would be canceled effective August 15, 1961.

Subsequently, by letter from the Secretary of the Commission, Kreifels was placed on notice that his highway common carrier operative rights would be subject to suspension or revocation, pursuant to lawful procedures, should he fail to maintain a classification in effect. The publishing agent filed with this Commission Supplement No. 25 to its classification eliminating Kreifels as a participating carrier therein effective August 15, 1961. The carrier has not filed a classification to replace the canceled classification.

Section 486 of the Public Utilities Code requires that common carriers of property file with this Commission schedules showing their rates and classifications, and Section 493 of the Code provides that no common carrier shall engage or participate in the transportation of property until its schedules of rates and classifications have been filed.

The required classification not being on file and the Commission being of the opinion and finding that such failure constitutes good cause for the suspension of this carrier's certificate,

IT IS ORDERED that:

(1) The certificate of public convenience and necessity to operate as a highway common carrier granted to Carl P. Kreifels, doing business as Geneva Transfer & Drayage Co., by Decision No. 45499 dated March 27, 1951, as amended by Decision No. 45647 dated May 1, 1951, in Application No. 30449, is hereby suspended pending further order.


(2) All tariffs issued by or on behalf of Carl P. Kreifels, doing business as Geneva Transfer & Drayage Co., are hereby suspended pending further order. A copy of this order shall be filed with said tariffs in the office of the Commission.


The Secretary is directed to cause service of a certified copy of this order to be made upon Carl P. Kreifels or to mail a certified copy thereof to him at his last known address as shown in the Commission's records.


The effective date of this order shall be the twentieth day after such service or after the above mailing, as the case may be, unless before such effective date Carl P. Kreifels shall have filed with this Commission a written response to this order denying the


facts set forth herein or shall have filed the proper and lawful freight classification as required by Sections 486 and 493 of the Public Utilities Code in which event the effective date of this order shall be stayed until further order of the Commission.
