SECOND INTERIM OPINION AND ORDER

Ordering Paragraph 1 of the Commission's Interim Decision No. 60283, dated June 20, 1960, and effective June 30, 1960, limited the service of water by Camp Meeker Water System, Inc., to the service connections existing as of the effective date of that order "until a showing has been made, satisfactory to the Commission, that there is available an adequate supply of water for any requested new connections in addition to all consumers then being served, and the Commission, upon such showing, shall first have modified this order."

It has come to the attention of the Commission that there are at least two requests<sup>1/</sup> for service, which the utility has refused to grant because of the limitation of service placed upon it by the Commission.

Other ordering paragraphs of the said Decision No. 60283, among other things, required the respondent herein to make measurements of the production of the several sources of supply of water and of the amount of water in storage; to endeavor to augment the supply, storage and distribution of water; and to render certain written reports periodically to the Commission.

A memorandum dated November 1, 1961, which is hereby made a part of the record in this matter as Exhibit No. 18, sets forth the results of a field investigation made by a Commission staff engineer and his evaluation of the reports filed by respondent in compliance with the said decision. The memorandum states that the water system has been able to meet customer demands during the last two summers, even on critical weekends, and recommends that the utility be allowed to serve five additional customers.

Therefore, IT IS HEREBY ORDERED as follows:

1. That the restriction imposed by ordering Paragraph 1 of Decision No. 60283 be, and it is, modified to permit respondent to serve five new, or additional, water consumers.

2. That ordering Paragraph 9 of Decision No. 60283 be, and it is, modified by relieving respondent from the necessity of making the measurements and rendering the reports as heretofore required therein, except that respondent shall make such measurements and render written reports thereon for the months of June, July and August, 1962.

3. That on or before May 15, 1962, respondent shall file with the Commission a written report indicating:

- (a) Details of any and all improvements to the water system made since August 1, 1961.
- (b) Information pertaining to the procurement of any additional water supplies not previously reported to the Commission and plans for obtaining additional water sources during the summer of 1962.
- (c) A plan for providing additional storage facilities at an elevation which will augment the storage in the area now served from the California tanks.

- (d) A plan for the installation of a pipeline capable of delivering water from the Acreage and Dutch Bill Creek wells to the additional storage to be provided according to the plan in subparagraph 3(c) hereof.

Because of the urgent needs for service of the two applicants hereinabove named, the effective date of this order shall be the date hereof.
