## ORDER REVOKING OPERATIVE RIGHT

The certificate of public convenience and necessity acquired by Gramel Company, Inc., has been suspended since November 17, 1960, for failure to have on file requisite evidence of liability insurance! The carrier has not filed the required evidence of liability insurance since that date.

Gramel Company, Inc., having failed to have on file the required evidence of liability insurance and the Commission being of the opinion and finding that such failure constitutes good cause for the revocation of the certificate and cancellation of the tariffs applicable to the services thereunder and related power of attorney,

IT IS ORDERED that:

(1) The certificate of public convenience and necessity acquired by Gramel Company, Inc., by Decision No. 60580 dated August 16, 1960, in Application No. 42363, is hereby revoked.

The certificate authorizes service as a petroleum irregular route carrier for the transportation of petroleum and petroleum products in tank trucks and tank trailers between all points and places in the State of California.

(2) Power of Attorney AFL No. 1 issued by Gramel Company, Inc., in favor of Western Motor Tariff Bureau, Inc., is hereby canceled.

(3) Western Motor Tariff Bureau, Inc., Agent, is hereby authorized and directed to cancel the participation of Gramel Company, Inc., from its tariffs on file with this Commission, said cancellation to be made within 90 days after the effective date of this order, and on not less than five days' notice to the Commission and the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Gramel Company, Inc., or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to Western Motor Tariff Bureau, Inc.

The effective date of this order shall be the thirtieth day after such service upon Gramel Company, Inc., or after the above mailing to Gramel Company, Inc., as the case may be, unless before such effective date there shall have been filed with this Commission a written response to this order denying the facts set forth herein, or requesting public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
