O P I N I O N

On August 23, 1961, applicant filed an application for a radial highway common carrier permit.

On October 13, 1961, at San Francisco a hearing on this application was held and the matter submitted.

By Decision No. 62094 in Case No. 6327, dated June 6, 1961, the radial highway common carrier permit issued to Joseph Davi was revoked, effective August 15, 1961, for failure to comply with a prior Commission order requiring Joseph Davi to audit his records to ascertain if there were any undercharges other than those that had been found by the Commission staff.

The applicant testified that he has now performed the audit, no other undercharges were found, and the undercharges found by the Commission staff have been collected. The application lists assets of \$59,500 and liabilities of \$7,000. Included in the assets is motor trucking equipment valued at approximately \$50,000. The applicant seeks to serve an area within a 500 mile radius of Eureka

transporting lumber, forest products, cement, new automobiles, steel, building supplies, boats, pipe, canned goods, soda water and wine.

Findings and Conclusions

1. Applicant possesses the financial responsibility and experience to perform the operations proposed.

2. Orders of the Commission must be obeyed; they are for the protection of the public and the carriers. In this instance the application will be granted, but Joseph Davi is hereby placed on notice that a violation of any Commission rule, order or regulation will be dealt with promptly, and the past record of Joseph Davi for compliance with Commission rules, orders and regulations will be kept in mind.

O R D E R




Public hearing having been held and based upon the evidence therein adduced,

IT IS ORDERED that Application No. 43734 (Appl. No. 12-3162-R) is granted.

The Secretary of the Commission is directed to cause a permit to operate as a radial highway common carrier to be issued to Joseph Davi as prayed for in Application No. 43734 (Appl. No. 12-3162-R).
