By this application San Diego Transit System seeks authority to reroute its Route "5" - Clairemont-Market Street line as follows:

Route "5"

Southbound only via Columbia Street instead of State Street between Fir Street and Beech Street.

Applicant alleges that the rerouting herein proposed is not competitive with any other carrier; that copies of this application have been sent to the City Engineer and the Transportation and Traffic Engineer of the City of San Diego, to local authorities, and to other interested parties; that the rerouting herein proposed is necessary to conform with the plan of the City of San Diego to designate India Street and Kettner Boulevard, between Beech and Winder Streets as one-way streets; and that the proposed change will not result in changes in fares, schedules, or equipment operated.

The Commission having considered the matter, finds and concludes that public convenience and necessity require that applicant's Route "5" - Clairemont-Market Street line be rerouted as hereinafter set forth. The application will be granted. A public hearing is not deemed necessary.

<u> 0 R D E R</u>

Application having been made, the Commission being fully advised in the premises and having found facts as hereinabove set forth,

IT IS ORDERED that San Diego Transit System, a corporation, may reroute its Route "5" - Clairemont-Market Street, and Appendix A of Decision No. 55090 is further amended by the issuance of 5th Revised Page 25 in revision of Fourth Revised Page 25 of said Appendix A as attached hereto and made a part hereof.

Applicant shall, within sixty days after the effective date hereof and on not less than five days' notice to the Commission and to the public, amend its tariff and time schedule to reflect the authority herein granted.
