Clearances shall conform to the provisions of G.O. 26-D. Applicant is also authorized to alter the crossing of Bellam Boulevard and Jacoby Street at grade with a spur track of Northwestern Pacific Railroad Company (Crossing No. 5-16.3-C) near San Rafael, Marin County, as described in the application and substantially in accordance with the plan attached thereto. Grades of approach shall not be greater than one per cent. Construction shall be equal or superior to Standard No. 2 of G.O. No. 72. Protection shall be by the following provisions: (1) Four Standard No. 1 signs (General Order No. 75-B) reflectorized with reflex-reflective sheet material. - 1 -

MP A. 43682 (2) Appropriate railroad instructions as well as signs installed on the railroad approaches to said grade crossing that advise railroad operating personnel of the following requirement: No train, engine, motor or car shall be operated over said crossing unless said train, engine, motor or car shall be first brought to a stop and traffic on the highway protected by a member of the train crew or other competent employee acting as flagman. Maintenance cost outside of lines two feet outside of rails at Crossing No. 5-16.3-C shall be borne by applicant or the County of Marin. Northwestern Pacific Railroad Company shall bear maintenance cost at Crossing No. 5-16.3-C between such lines. Construction and all other maintenance expense for both crossings shall be borne in accordance with an agreement entered into between the parties relative thereto, and copy of said agreement, together with plans of said grade separation (Crossing No. 5-15.7-B) approved by Northwestern Pacific Railroad Company, shall be filed with the Commission within 180 days from the date hereof. Should the parties fail to agree, the Commission will apportion the cost of construction and maintenance by further order.
