Ross Starkey was granted a certificate of public convenience and necessity authorizing operations as a highway common carrier of general commodities. The following commodity exclusion is included in the certificate: "Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerated equipment." Under Decision No. 61177, dated December 13, 1960, in Case No. 5432, temperature control charges were established on "Commodities requiring protection from heat by the use of ice (either water or solidified carbon dioxide) or by mechanical refrigeration." By letter dated June 19, 1961, the carrier informed the Commission that he would have no objection to the revision of his certificate to make the commodity exclusion consistent with the application of the temporature control charges. The certificate will be amended accordingly. A public hearing is not necessary. Good cause appearing, IT IS ORDERED that: -1-
