SUPPLEMENTAL OPINION AND ORDER

By the decision hereinafter identified, Union Truck Co., Inc., was granted a certificate of public convenience and necessity authorizing operations as a highway common carrier of property. The following commodity exclusion is included in the certificate:

> "Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerated equipment."

Under Decision No. 61177, dated December 13, 1960, in Case No. 5432, temperature control charges were established on

> "Commodities requiring protection from heat by the use of ice (either water or solidified carbon dioxide) or by mechanical refrigeration."

By letter dated July 21, 1961, the carrier informed the Commission that it would have no objection to the revision of its certificate to make the commodity exclusion consistent with the application of the temperature control charges. The certificate will be amended accordingly. A public hearing is not necessary.

Union Truck Co., Inc., a corporation, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport property necessary or incidental to the establishment, maintenance, or dismantling of oil, gas or water wells, pipe lines, refineries, and cracking or casing head plants, and equipment and material used in construction and farming upon and along the following described routes, including all intermediate points, with the right to make lateral departures therefrom within a radius of 50 miles of such routes, provided that any service performed pursuant to the certificate herein granted is restricted to shipments moving to, from and between points and places in San Luis Obispo, Fresno, Kings, Santa Barbara, Ventura, Kern, Los Angeles, and Orange Counties, in California:
