ORDER TRANSFERRING PERMIT AND SUBSTITUTING RESPONDENTS IN COMMISSION INVESTIGATION

Earl W. Summers and Ray E. Summers are partners and presently operating as a radial highway common carrier under the name of North Coast Transport. The partnership presently holds Radial Highway Common Carrier Permit No. 12-2396.

The Summers have decided, for business reasons, to change their mode of doing business from a partnership to a corporation.

Application No. 44109 seeks authority to transfer Permit No. 12-2396 from the partnership to a corporation known as North Coast Transport, Inc.

There is presently pending before the Commission Case No. 6368, an investigation on the Commission's own motion into the operations, rates and practices of Ray and Earl Summers, copartners, doing business as North Coast Transport.

North Coast Transport, Inc., has filed with the Commission a certified copy of a resolution by its board of directors which takes note of the pending investigation in Case No. 6368 and binds the corporation to accept any penalty which may be assessed in the proceeding based upon the conduct of the partnership prior to incorporation.

In the circumstances, the proposed transfer appears to be for legitimate business reasons and will not thwart the jurisdiction of the Commission in Case No. 6368.

The Commission finds that a public hearing is not necessary in Application No. 44109 and that the transfer of Radial Highway Common Carrier Permit No. 12-2396 from Earl W. Summers and Ray E. Summers to North Coast Transport, Inc., a California corporation, is not adverse to the public interest.

The Commission further finds that North Coast Transport, Inc., should be substituted as the respondent in Case No. 6368 in place of Earl W. Summers and Ray E. Summers.

IT IS ORDERED that:

- 1. Radial Highway Common Carrier Permit No. 12-2396 is hereby transferred from Earl W. Summers and Ray E. Summers to North Coast Transport, Inc., a California corporation.
- 2. North Coast Transport, Inc., a California corporation, is hereby substituted as the respondent in Case No. 6368 in the stead of Earl W. Summers and Ray E. Summers.
