ORDER

Southern Pacific Company is authorized to construct a passing track at grade across South Avenue (near Fowler), Temperance Avenue (Goble), Mountain View Avenue (Wineland) and Bethel Avenue (near Wineland), respectively, in Fresno County, at the locations described in the application, each to be a portion of an existing main line grade crossing, in accordance with the following provisions:

- (2) Construction of said crossings shall be equal or superior to Standard No. 2 of General Order No. 72, without superelevation and of widths to conform to the portions of the avenues now graded, with tops of rails flush with the roadways.
- (3) Applicant shall bear entire construction and maintenance expense.

Within thirty days after completion pursuant to this order, applicant shall so advise the Commission in writing. This authorization shall expire if not exercised within one year unless time be extended or if above conditions are not complied with. Authorization may be revoked or modified if public convenience, necessity, or safety so require.

Applicant alleges that track construction work forces are completing nearby projects and desires early authorization to start construction of the project herein authorized in order to avoid unnecessary delay expense.

Therefore, the effective date of this order shall be the date hereof.
