SUPPLEMENTAL OPINION AND ORDER

Pacific Coast Terminal Warehouse Co., a corporation, holds prescriptive operative rights as a public utility warehouseman for the operation of storage or warehouse floor space of 243,800 square feet in Vernon determined by order of the Commission in Case No. 6776 dated August 9, 1960. Subsequently, by Decision No. 62985 dated December 27, 1961, in Application No. 44011, applicant was granted a certificate of public convenience and necessity to operate as a public utility warehouseman for the additional storage or warehouse floor space of 196,455 square feet, also in Vernon. For convenience and to simplify record keeping, these separate operative rights will be restated as a single certificate of public convenience and necessity.

Good cause appearing,

IT IS ORDERED that:

(1) A certificate of public convenience and necessity is hereby granted to Pacific Coast Terminal Warehouse Co., a corporation, authorizing it to operate as a public utility warehouseman, as defined in Section 239(b) of the Public Utilities Code, for the operation of storage or warehouse floor space as more particularly set forth in Appendix A attached hereto and by this reference made a part hereof.

(2) The certificate of public convenience and necessity granted in paragraph (1) of this order supersedes the operative right determined in Case No. 6776 dated August 9, 1960, and the certificate of public convenience and necessity granted by Decision No. 62985, which operative right and certificate are hereby revoked.

This order shall become effective twenty days after the date hereof.
