In the Matter of the Joint Application of SUBURBAN WATER SYSTEMS and VALLECITO WATER COMPANY for exchange of portions of service area and for certificates of public convenience and necessity.

FIRST SUPPLEMENTAL ORDER

Good cause appearing, IT IS HEREBY ORDERED that ordering paragraph 1 of the Interim Order of Decision No. 63116, dated January 16, 1962, in Application No. 43578, is amended to read as follows:

1. A certificate of public convenience and necessity is granted to Vallecito Water Company to construct and operate a public utility water company in that portion of Los Angeles County, California, described as follows:

That portion of Lot 15 of Tract 3366, as shown by map recorded in Book 37, Pages 12 and 13 of Maps, Records of Los Angeles County, California; and that portion of Lot 8 of the J. W. Hudson Tract, as shown by map recorded in Book 12, Page 148 of Maps, Records of said County, described as a whole as follows: Beginning at the most westerly corner of Lot 43, Tract No. 24451, as per map recorded in Book 655, Pages 39-42 of Maps, Records of said County; thence along the southeasterly line of said tract South 51° 58' 00" East, a distance of 320.47 feet, to the most southerly corner of Lot 44 of said tract; thence North 36° 25' 00" East, a distance of 114.00 feet, to the most southerly corner of Lot 45 of said tract; thence along the southeasterly line of said lot North 79° 25' 00" East, a distance of 93.00 feet; thence northerly along the easterly

line of said lot, North a distance of 57.35 feet, to the most southerly corner of Lot 46 of said tract; thence along the southeasterly line of said tract, North $61^{\circ} 57' 00''$ East, a distance of 362.21 feet, to a point on the easterly line of Lot 15, Tract No. 3366, as per map recorded in Book 37, Pages 12-13 of Maps, records of said county; thence South $7^{\circ} 07' 30''$ East, a distance of 294.00 feet; thence South $82^{\circ} 52' 30''$ West, a distance of 35.27 feet, to a point on the easterly line of said Lot 15; thence continuing South $82^{\circ} 52' 30''$ West a distance of 97.58 feet; thence South $26^{\circ} 00' 00''$ East, a distance of 120.00 feet; thence South $47^{\circ} 15' 00''$ West a distance of 112.00 feet; thence South $13^{\circ} 33' 38''$ East, a distance of 188.36 feet, to a point on a curve concave southwesterly and having a radius of 148.00 feet, said last mentioned course being radial to said curve; thence along said curve through an angle of $52^{\circ} 03' 38''$ a distance of 134.48 feet; thence radial to said curve North $38^{\circ} 30' 00''$ East, a distance of 157.00 feet, thence South $20^{\circ} 00' 00''$ East a distance of 300.00 feet, thence South $52^{\circ} 30' 00''$ East, a distance of 175.00 feet; thence South a distance of 249.12 feet, to a point on the southerly line of Lot 8 of said Tract No. 3366, said point being distant North $89^{\circ} 43' 50''$ East, 379.16 feet from the southwest corner of said lot; thence along said line South $89^{\circ} 43' 50''$ West, a distance of 1940 feet more or less to the intersection of said southerly line with elevation contour 650.00 feet, said point of intersection being distant easterly along said southerly line 120.00 feet more or less from the center line of Hacienda Boulevard and 890 feet more or less southeasterly from the intersection of Richview Drive with Hacienda Boulevard; thence in a general northerly direction along said contour 650 feet to its intersection with the southerly boundary of said Tract 24451; thence along said boundary to the most southerly corner of Lot 39 of said Tract No. 24451; thence along the southeasterly line of said tract,

North 24° 18' 00" East a distance of 335.00 feet, to the point of beginning.

The effective date of this order shall be the date hereof.
