## OPINION AND ORDER

The Greyhound Corporation requests authority to amend its Urban Routes Nos. 3.01, 3.02, 3.03 and 3.04 within the City of Dixon.

It is alleged that applicant's station in the City of Dixon is operated by an independent commission agent who has constructed a new improved and modern agency facility at 320 West "A" Street, one block west of the present agency station; that the new station will be open and ready for operation on or about March 1, 1962; and that use of the new station will necessitate the amendment of the aforesaid routes.

After consideration, the Commission finds and concludes that public convenience and necessity require the granting of the application. A public hearing is not necessary.

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to The Greyhound Corporation, authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public

Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in First Revised Page 67 attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55893 and particularly to the provisions set forth in Section 3 of Appendix A thereof.

2. Appendix A of Decision No. 55893 is hereby amended by incorporating First Revised Page 67 in revision of Original Page 67.

3. In providing service pursuant to the certificate granted in ordering paragraph 1 hereof, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- (b) Within one hundred and twenty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, applicant shall establish the service herein authorized and shall file in triplicate, and concurrently make effective, tariffs and timetables reflecting the authority herein granted.

- \*UR-3.01 Entering Dixon southbound from Milk Farm, over unnumbered highway to junction North Adams Street, thence over North Adams Street to junction West A Street, thence over South Adams Street to junction unnumbered highway, thence over unnumbered highway to southwestern City Limits of Dixon, en route to Midway.
- \*UR-3.02 From junction U. S. Highway 40 and West A Street (West Dixon), over West A Street to driveway to company station.
- \*UR-3.03 From junction North Adams Street and West B Street, over West B Street to driveway to company station.
- \*UR-3.04 From junction South Adams Street and Porter Road, over Porter Road to driveway to company station.
