Application of THE GREYHOUND CORPORATION for authority to establish an additional urban route in the City of Sacramento, County of Sacramento.

Application No. 44203

OPINION AND ORDER

The Greyhound Corporation requests authority to establish a new urban route in the City of Sacramento between the intersection of Capitol Avenue and Ninth Street and the intersection of Capitol Avenue and Eighth Street.

It is alleged that the City of Sacramento has converted Eighth Street from a two-way street to a one-way street for traffic moving in a northerly direction and to facilitate the movement of schedules in both directions it is now necessary to operate over Capitol Avenue between Eighth and Ninth Streets in order to conform to the one-way street pattern.

After consideration the Commission finds and concludes that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary. Therefore,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to The Greyhound Corporation, authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Second Revised Page 77, attached hereto, as an extension and enlargement of, consolidation with and

subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

2. Appendix A of Decision No. 55893 is hereby amended by incorporating Second Revised Page 77 in revision of First Revised Page 77.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- b. Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission, which tariff and timetable filings shall be made effective concurrently with the establishment of the service and on not less than thirty days' notice to the Commission and the public. The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.
