In the Matter of the Application of A. E. RYAN dba PENINSULA BUS LINES for certificate of public convenience and necessity to operate passenger stage service in South San Francisco and vicinity serving new El Camino High School.

Application No. 44206 (Filed February 21, 1962)

<u>OPINION</u>

By this application, A. E. Ryan requests authority to establish and operate, and consolidate with his present service in this area, a passenger stage transportation service in South San Francisco, primarily to and from the new El Camino High School. Applicant proposes to charge 15¢ per passenger, which fares are the same as those set forth in tariffs now on file with the Commission. The proposed schedules will conform to the opening and closing hours of said high school. His present equipment will be used and he has shown that he is financially able to perform this operation. There are no other passenger stage corporations operating locally in this area.

Public hearing is not necessary. Upon consideration of the allegations of the application and of a recommendation by the Commission staff made after a study of the area and its needs, the Commission finds and concludes as follows:

1. Applicant possesses the experience, equipment, personnel and financial resources to institute and maintain the proposed service.

2. Public convenience and necessity require that the application be granted as set forth in the ensuing order.

O R D E R

Application having been filed and the Commission having considered the allegations thereof,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to A. E. Ryan authorizing him to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes more particularly set forth in Original Page 5 to be added to Appendix A to Decision No. 53998 dated October 30, 1956, as amended, such new page 5 to be in the form of Appendix A hereto attached and by reference made a part hereof and such routes to be consolidated with applicant's other operations.

2. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

(a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that he will be required, among other things, to file annual reports of his operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98 and insurance requirements of/ the Commission's General Order No. 101-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 98 and 101-A, may result in a cancellation of the operating authority granted by this decision.

 - (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission, which tariff and timetable filings shall be made effective concurrently with the establishment of the service and on not less than thirty days' notice to the Commission and the public. The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.

The effective date of this order shall be twenty days after the date hereof.

Beginning at the intersection of Camaritas Avenue and Arroyo Drive; thence via Camaritas Avenue, El Campo Drive, Alta Mesa Drive, Arroyo Drive, Junipero Serra Boulevard, Hickey Boulevard, to El Camino Real and northerly along El Camino Real to Mission Road; thence southerly along Mission Road to the new El Camino High School at the intersection of Evergreen Drive; thence continuing along Mission Road, Grand Avenue, Orange Avenue to a terminus at El Camino Real and Orange Avenue. Return via reverse of route.
