ORDER REVOKING OPERATIVE RIGHTS

The certificate of public convenience and necessity granted to T. A. Smith, doing business as T. A. Smith Trucking, has been suspended since March 21, 1961, for failure to have on 1 file requisite evidence of liability insurance. The carrier has not filed the required evidence of liability insurance since that date.

The certificate of T. A. Smith having been suspended for more than a year for his failure to have on file the required evidence of liability insurance, and the Commission being of the opinion and finding that such failure constitutes good cause for the revocation of the certificate and cancellation of the tariffs applicable to the services thereunder and related power of attorney,

The certificate authorizes service as a petroleum irregular route carrier for the transportation of petroleum and petroleum products, including oil-based drilling fluids and drilling muds, oil and oil-based chemicals for drilling purposes, road oils and oil-contaminated waste products only in vacuum or pump-type trucks and trailers with pumps or compressors attached, and only in connection with and incidental to the drilling, maintenance, reconditioning or abandonment of an oil well or an oil well site, or in connection with the servicing of its facilities or roads leading thereto, or in connection with the repair of a pipeline break, between all points and places in Ventura and Santa Barbara Counties and that portion of Kern County south of State Highway No. 166 and within a twenty-mile radius of Castaic Junction.

IT IS ORDERED that:

1. The certificate of public convenience and necessity granted to T. A. Smith, doing business as T. A. Smith Trucking, by Decision No. 50330 dated July 27, 1954, in Application No. 35316, is hereby revoked.

2. Power of Attorney AFL No. 1 issued by T. A. Smith in favor of C. R. Nickerson is hereby canceled.

3. C. R. Nickerson, Agent, is hereby authorized and directed to cancel the participation of T. A. Smith, doing business as T. A. Smith Trucking, from his tariff on file with this Commission, said cancellation to be made within 90 days after the effective date of this order, and on not less than five days' notice to the Commission and the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon T. A. Smith or to mail a certified copy thereof to him at his last known address as shown in the Commission's records and to mail a copy of this order to C. R. Nickerson.

The effective date of this order shall be the thirtieth day after such service upon T. A. Smith or after the above mailing to T. A. Smith, as the case may be, unless before such effective date there shall have been filed with this Commission
