ORDER REVOKING OPERATIVE AUTHORITY

It appearing that, by Decision No. 61619 dated March 7. 1961, as amended by Decision No. 61733 dated March 28, 1961, in Application No. 42659, as amended, Herman Strauss and Louis J. Prischmann were granted a passenger stage operative right authorizing service between U. S. Naval Station, Treasure Island, San Francisco and the Oakland and San Francisco International Airports; that an order extending time within which tariffs and timetables were required to be filed was issued July 25, 1961, thereby extending such time to November 2, 1961; that a second order extending time was issued February 26, 1962, thereby extending such time to April 17, 1962, that, since April 17, 1962, Herman Strauss and Louis J. Prischmann have had no evidence on file with this Commission showing adequate protection against liability imposed by law for payment of damage for personal injury or property damage as required by General Order No. 101-A; that they have no timetables or tariffs on file with this Commission; and that the authorized service has not been operated.

Therefore, it is hereby found that Herman Strauss and Louis J. Prischmann are not conducting and in fact have never conducted passenger stage operations between U.S. Naval Station, Treasure Island, San Francisco and the Oakland and San Francisco International Airports.

Prischmann, or upon their attorneys, or after the above mailing to the estate of Herman Strauss and to Louis J. Prischmann or to their attorneys, as the case may be, unless before such effective date there shall have been filed with this Commission a written response to this order denying the facts set forth herein, or requesting public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
