SECOND SUPPLEMENTAL OPINION AND ORDER

By Decision No. 61714, dated March 21, 1961 herein, the Commission granted to John Pestana a certificate of public convenience and necessity for a water system in Santa Cruz Gardens, Tract No. 230, approximately one mile east of the City of Santa Cruz. Ordering paragraph 7 limited service to Tract No. 230. Applicant now seeks authority to serve an adjacent Tract No. 323, called Santa Cruz Gardens Tract No. 2, Unit No. 1.

Since the original certificate grant, applicant has expanded his production. He has stated in a letter to the Commission that he is now expanding his storage facilities. The proposed extension has been engineered to comply with General Order No. 103.

The extension will be made under applicant's filed extension rule. The Commission finds that public convenience and necessity require that the request be granted.

A public hearing is not necessary.

Therefore, good cause appearing,

IT IS ORDERED that:

1. Ordering paragraph 7 of Decision No. 61714, dated March 21, 1961, in Application No. 42652 is modified to the extent of permitting applicant to furnish water service to Tract No. 323, Santa Cruz County.

2. Applicant is authorized to file with this Commission, after the effective date of this order and prior to the date service is first furnished to the public in Tract No. 323, Santa Cruz County, in conformity with General Order No. 96-A and in a manner acceptable to this Commission, such revised tariff sheets, including tariff service area map, as are necessary to provide for the application of his present tariff schedules to the area herein authorized to be served. Such revised tariff sheets shall become effective upon five days' notice to the Commission and to the public after filing as hereinabove provided.

3. Except as modified by this order, the service restriction contained in ordering paragraph 7 of Decision No. 61714 shall otherwise be and remain in full force and effect.

The effective date of this order shall be the date hereof.
