GF Appendix A CLARENCE SMITH and ABBIE SMITH First Revised Page 1 Cancels Original Page 1 Clarence Smith and Abbie Smith, by the certificate of public convenience and necessity granted in the decision noted in the margin, are authorized to transport general commodities between all points in the Los Angeles Basin Territory as described in Appendix B attached hereto. Applicants shall not transport any shipments of: Used household goods and personal effects not packed in accordance with the crated property requirements set forth in paragraph (d) of Item No. 10-C of Minimum Rate Tariff No. 4-A. 2. Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis. Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine. Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerator equipment. Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids in bulk, in tank trucks, tank trailers, tank semitrailers or a combination of such highway vehicles. 6. Commodities when transported in bulk in dump truck or hopper-type trucks. 7. Commodities when transported in motor vehicles equipped for mechanical mixing in transit. Commodities of abnormal size or weight which because of such size or weight require the use of and are transported on low-bed trailers.
