## CPINION AND ORDER

Santa Barbara Transit Company requests authority to amend several of its routes and time schedules.

The amendments would result in rerouting Routes Nos. 1, 2-5, and 7-8 and several schedule adjustments.

Copies of the application were served upon the Board of Supervisors and the City Council of Santa Barbara. No protest has been received.

After consideration, the Commission finds and concludes that public convenience and necessity require the granting of the authority sought. Applicant's request that it be authorized to make the necessary tariff and timetable filings on fifteen days' notice to the Commission and to the public will be granted. A public hearing is not necessary.

Therefore, good cause appearing,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Santa Barbara Transit Company authorizing the establishment and operation of service as a passenger stage

corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers between the points and over the routes as set forth in Second Revised Page 3, Third Revised Page 7 and Third Revised Page 11, attached hereto.

2. Appendix A of Decision No. 53442 is hereby amended by incorporating said Second Revised Page 3, Third Revised Page 7 and -Third Revised Page 11 in revision of First Revised Page 3, Second Revised Page 7 and Second Revised Page 11.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenses and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the safety rules and other regulations of the Commission's General Order No. 98 and insurance requirements of the Commission's General Order No. 98 and insurance requirements of the Commission's General Order No. 98 and insurance requirements of the commission's General Order No. 98 and insurance requirements of the commission's General Order No. 101-A. Failure to file such reports, in such form and at such time as the Commission may direct, or to comply with and observe the provisions of General Orders Nos. 98 and 101-A, may result in a cancellation of the operating authority granted by this decision.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file in the Commission's office in triplicate tariffs and timetables satisfactory to the Commission.
- (c) The tariff and timetable filings shall be made effective not earlier than fifteen days after the effective date of this order on not less than fifteen days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.


