## OPINION

Applicant requests authority to carry out the terms and conditions of three contracts for extension of water facilities to serve four parcels of land situated above the 165-foot contour of its Sweetwater District system, in San Diego County.

The contracts are similar to a number of agreements recently authorized by the Commission, wherein, pursuant to prior understandings between applicant and South Bay Irrigation District, developers of lands above the 165-foot contour within the district's original and annexed boundaries have agreed to contribute costs of extending water service by applicant without the refunds contemplated by the utility's water main extension rule. The developers in the instant application have indicated their understanding of the rule deviations involved and have joined with applicant in requesting authorization of the contracts, copies of which are
