## OPINION AND ORDER

In this application Pacific Water Co. reports that in 1961 it issued its 90-day, 6-1/2 percent notes to Bank of America National Trust and Savings Association in the amount of \$40,000 for the purpose of financing the cost of additions and improvements to its water system and that it now desires authority to renew the notes from time to time.

The Commission has considered this matter, has determined that a public hearing is not necessary and is of the opinion that the money, property or labor to be procured or paid for by the issue of the notes herein authorized is reasonably required for the purpose specified herein, and that such purpose is not, in whole or in part, reasonably chargeable to operating expenses or to income; therefore,

- Pacific Water Co., on or after the effective date hereof, may issue its notes in the aggregate principal amount of not to exceed \$40,000, under the terms and for the purpose specified herein, and may renew said notes
- Pacific Water Co. shall file with the Commission a report, or reports, as required by General Order No. 24-A, which order, insofar as 2. applicable, is made a part of this order.
- 3. The authority herein granted shall become effective when Pacific Water Co. has paid the fee prescribed by Section 1904(b) of the Public Utilities Code, which fee is \$40.

The authority herein granted is for the issue of notes and is not to be construed as indicative of amounts to be included in a future rate base for the determination of just and reasonable rates.
