## OPINION

Applicant requests authority to reroute its Route "ll" Adams Avenue-Logan Heights line between the intersection of
lst Avenue and Ivy Street and the intersection of 2nd Avenue and
Beech Street by way of Ivy Street and 2nd Avenue instead of
lst Avenue and Beech Street. This change is made necessary by
reason of a change in traffic pattern due to the city having
changed lst Avenue between Market Street and Grape Street to a
one way street.

The Commission finds that the proposed route change is in the public interest. The application will be granted. A public hearing is not necessary.

## ORDER

IT IS ORDERED that San Diego Transit System, a corporation, may change its Route "ll" - Adams Avenue-Logan Heights line as set forth herein, and Appendix A of Decision No. 55090 is hereby further amended by incorporating therein Fourth Revised Page 29, attached hereto and made a part hereof, in revision of Third Revised Page 29.
