Southern Pacific Company requests authority to discontinue a substitute bus service, presently being performed by The Greyhound Corporation, between Dunsmuir and Hilt. In the event the authority sought by Southern Pacific is granted, The Greyhound Corporation requests that its operating authority between Yreka and Grenada Junction via Montague and its authority to serve Southern Pacific rail stations at Hornbrook and Hilt be revoked.

A public hearing was held before Examiner Thomas E. Daly on June 13, 1962, at Yreka.

Decision No.

By Decision No. 46494 dated December 4, 1951, in Application No. 32545, Southern Pacific Company was authorized to discontinue the operation of its passenger trains Nos. 327 and 328 between Black Butte, California, and the California-Oregon State Line near Hilt, California, subject to the following condition:

> "(2) Abandonment of rail service as herein authorized shall be made concurrently with the establishment of substitute motor coach service to points along U. S. Highway No. 99, with the exception of a detour from Grenada via Montague to Yreka, and also providing direct service to Hornbrook and Hilt railroad stations."

Pursuant to the requirements of Decision No. 46494, Southern Pacific Company entered into an agreement with The Greyhound Corporation to provide, as a substitute for trains Nos. 327 and 328, bus service connecting with the "Shasta Daylights" at Dunsmuir and serving the same points as the two trains.

By Decision No. 46720, dated February 5, 1952, The Greyhound Corporation was authorized to operate a passenger stage service between Grenada Junction and Yreka and intermediate points, over an unnumbered county road via Grenada and Montague, and serving Southern Pacific rail stations at Hornbrook and Hilt by diversion from U. S. Highway 99.

By its application Southern Pacific Company requests that Decision No. 46494 be revised by deleting therefrom condition (2), because the demand for the substitute bus service is not sufficient to justify its continuance. A. 44125, A. 44134 AH

Under the agreement with The Greyhound Corporation, Southern Pacific Company must pay a compensation in the minimum sum of fifty cents per bus mile for each bus mile operated, with a minimum of \$120 per day on the basis of two motor coaches being assigned to the operation. According to Exhibit 2 the following is a statement of income, expense and bus miles operated with respect to the substitute bus service for the years 1952 through 1961, inclusive:

The reduction in loss since 1959 is the result of the "Shaste Daylight" being operated on a tri-weekly basis from September to June of each year, except for a month at Christmas time when daily service is provided.

In the event the substitute bus service is discontinued, The Greyhound Corporation would provide its regular bus service along U. S. Highway 99 with stops at Hilt Junction (located one mile from Hilt); Henley Station (located approximately one mile from Hornbrook); Yreka (located approximately six miles from Montague); and Grenada Junction (located approximately 3/4 of a mile from Grenada). At the present time The Greyhound Corporation operates 12 schedules daily between Dunsmuir and Grants Pass.

Although both applicants published and posted notice of the hearing in this matter no appearance was made in protest to the authority sought.

After consideration the Commission finds and concludes that there is not sufficient public use of the substitute bus service to warrant its continuance and that granting the relief sought by the applicants herein would not be adverse to the public interest.

## <u>O R D E R</u>

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED that:

1. After the effective date hereof Southern Pacific Company is hereby authorized to discontinue substitute bus service between Dunsmuir and Hilt and Decision No. 46494 is hereby amended by deleting therefrom condition (2) as heretofore quoted.

2. Concurrent with the discontinuance of service authorized in ordering paragraph 1 hereof The Greyhound Corporation is hereby authorized to discontinue service over Route No. 1.03 between Yreka and Grenada Junction via Montague, and is further authorized to discontinue service over Route No. 1.01 insofar as it is authorized to deviate from said route to serve Southern Pacific rail stations at Hornbrook and Hilt. The authority to provide said service is hereby revoked.

3. Appendix A of Decision No. 55893 is hereby amended by incorporating Second Revised Page 2, attached hereto, in place of First Revised Page 2.

4. For a period of not less than fourteen days prior to the discontinuance of service as authorized by ordering paragraphs 1 and2 hereof Southern Pacific Company and The Greyhound Corporation

shall post proper notice in the appropriate terminals, depots and equipment.

5. After the effective date hereof and on not less than thirty days' notice to the Commission and the public applicants shall amend their tariffs and timetables presently on file with this Commission to reflect the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.

SECTION I - INTERCITY ROUTES AND SPECIAL CONDITIONS

#### ROUTE GROUP 1

\*1.01 - Between the Oregon-California State Line north of Yreka, and South Woodland Junction:

> From the point where U. S. Highway 99 intersects the Oregon-California State Line, over U. S. Highway 99 to Red Bluff, thence over U. S. Highway 99W to junction U. S. Highway 40 (South Woodland Junction).

1.02 - Detween the Cregon-California State Line north of Dorris, and Weed:

> From the point where U. S. Highway 97 intersects the Oregon-California State Line, over U. S. Highway 97 to junction U. S. Highway 99 (Weed).

- \*1.03 Intentionally left blank.
- 1.04 Between junction U. S. Highway 99W and California Highway 21 southeast of Dunnigan, and junction California Highway 21 and U. S. Highway 40 northeast of Vacaville:

From junction U. S. Highway 99W and California Highway 21, over California Highway 21 to junction U. S. Highway 40.

No service may be rendered to or from intermediate points on this route other than East Winters.
