## <u>o p i n i o n</u>

A Commission staff member having determined, after examination as provided in Section 5135 of the Public Utilities Code, that Gilbert Camarillo, applicant's "responsible managing employee," had failed to qualify for a household goods carrier permit, the matter was set for hearing at Los Angeles, on August 1, 1962, before Examiner Chiesa.

At the hearing a Commission witness testified that, on June 6, 1962, Ralph E. McKean, who had in the meantime replaced Gilbert Camarillo as applicant's managing employee, was given an examination as provided in said code section and that said employee passed the examination, and as a result applicant has now qualified for a permit.

A financial statement filed with the application shows that on January 25, 1962, applicant's assets were \$23,025 and his liabilities \$12,000.

Protestant assisted in the development of the record. It presented no evidence in its own behalf.


Upon consideration of the application, examination, and the evidence of qualification presented at the hearing, the Commission finds that applicant possesses the requisite qualifications and financial resources and responsibility to perform the services of a household goods carrier as set forth in the following order.

IT IS ORDERED that on the effective date of this decision the Secretary of the Commission is directed to cause Household Goods Carrier Permit No. 19-55064 to be issued to Paul Munoz. Said permit is issued upon the following condition:

If Ralph E. McKean ceases to be connected with Paul Munoz, the latter shall notify the Commission in writing within thirty days after such cessation. If notice is given, the permit shall remain in force a reasonable length of time in order that another representative of applicant may be qualified before the Public Utilities Commission. If Paul Munoz fails to

notify the Commission of such cessation within a thirty-day period, at the end of that period the permit shall be automatically suspended.

The effective date of this order shall be twenty days after the date hereof.
