Decision No. 64363

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Application of THE GREYHOUND CORPORATION for authority to reroute passenger stage service between South Healdsburg Junction and North Santa Rosa Junction, Sonoma County, over relocated U. S. Highway 101, and for incidental relief.

<u>opinion</u>

The Greyhound Corporation requests the following authority:

- (a) To adopt relocated U. S. Highway 101 between South Healdsburg Junction and North Santa Rosa Junction.
- (b) To eliminate on-call service for five or more adult fares over Route No. 8.04 via Windsor.
- (c) To eliminate on-call service for five or more adult fares over Route No. 8.05 via Fulton.
- (d) To readopt former U. S. Highway 101 between Mark West Road Junction and North Santa Rosa Junction as a segment of Route No. 7.02.

It is alleged that U. S. Highway 101 is in process of construction as a limited-access freeway and a segment thereof has been relocated between South Healdsburg Junction and North Santa Rosa Junction which will be completed and open for public use on or about November 1, 1962; that the distance between South Healdsburg Junction and North Santa Rosa Junction over the relocated highway and former U. S. Highway are both approximately 14.5 miles; that the distances on the on-call routes to and from Windsor and Fulton are 0.9 of a mile and 2.7 miles, respectively; that the proposals herein require the elimination of all present

tariff points between Healdsburg and Santa Rosa, except East Windsor, and the adoption of a new tariff point at Fulton; that the present tariff points are not communities or centers of population, but are little more than county road intersections to which names were given in the early days of bus operation; and that the long-distance passengers traveling between San Francisco and the California-Oregon State Line will benefit substantially from the adoption of the relief requested.

After consideration the Commission finds that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary.

ORDER

Application having been filed and the Commission being informed in the premises,

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to The Greyhound Corporation, authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Second Revised Page 13 and Sixth Revised Page 15, attached hereto, as an extension and enlargement of, consolidation with and subject to all the limitations and restrictions set forth in the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

7.01 - Between Calistoga and Vallejo:

From Calistoga, over California Highway 29 to Vallejo.

*7.02 - Between Calistoga and North Santa Rosa Junction:

From Calistoga, over unnumbered highway via Mark West Springs to junction U. S. Highway 101 (North Santa Rosa Junction).

7.03 - Between Santa Rosa and Shellville:

From Santa Rosa, over California Highway 12 to Warfield, thence over unnumbered highway via Glen Ellen, Madrone, Hanna Center School, and Agua Caliente to Agua Caliente Junction, thence over California Highway 12 to Verano, thence over unnumbered highway via El Verano to El Verano Junction, thence over California Highway 12 to Shellville.

7.04 - Between Warfield and Agua Caliente Junction:

From Warfield, over California Highway 12 to Agua Caliente Junction, to be operated as an alternate route.

7.05 - Between Verano and El Verano Junction:

From Verano, over California Highway 12 to El Verano Junction, to be operated as an alternate route.

7.06 - Between Napa and Four Corners:

From Napa, over California Highway 12 to Vineburg Junction, thence over unnumbered highway via Vineburg to junction California Highway 12 (Four Corners).

ROUTE GROUP 8

*8.01 - Between the Oregon-California State Line north of Smith River, and Santa Rosa:

From the point where U. S. Highway 101 intersects the Oregon-California State Line, over U. S. Highway 101 to junction U. S. Highway 199, thence over U. S. Highway 101-199 to Crescent City, thence over U. S. Highway 101 to junction unnumbered highway (North Healdsburg Junction), thence over unnumbered highway via Healdsburg to junction U. S. Highway 101 (South Healdsburg Junction), thence over U. S. Highway 101 to North Santa Rosa Junction, thence over Business U. S. Highway 101 to Santa Rosa.

8.02 - Between the Oregon-California State Line north of Hazelview, and Crescent City:

From the point where U. S. Highway 199 intersects the Oregon-California State Line, over U. S. Highway 199 to Crescent City.

8.03 - Between Fort Bragg and Cloverdale:

From Fort Bragg, over California Highway 1 to junction California Highway 128, thence over California Highway 128 to junction U. S. Highway 101 (Cloverdale).
