In the Matter of the Application of Southern California Freight Lines, Inc., a California corporation, for an in lieu Certificate of Public Convenience and Necessity to consolidate and extend its highway common carrier authority as granted by previous decisions of the Public Utilities Commission.

<u>OPINION</u>

Applicant seeks herein an in lieu certificate of public convenience and necessity so as to consolidate in one certificate the highway common carrier operating authority which it has been granted over a period of 35 years by numerous decisions of this Commission. The application was filed pursuant to an order of this Commission in Decision No. 61727 (Applications Nos. 41429 and 41430).

The Commission finds that it would be of benefit to applicant, the shipping public and the Commission in the performance of its regulatory functions if all of applicant's highway common carrier operating rights were consolidated in an in lieu certificate of public convenience and necessity. In order to amalgamate the various territorial operating authorities and commodity descriptions in the certificates now held by applicant, it has been necessary to make a few minor adjustments in these operating rights. However, the purpose of the certificate hereinafter granted is to restate applicant's present operating rights and not to enlarge them. In the circumstances, the Commission finds that a public hearing is not necessary and that public convenience and necessity require that the application should be granted as hereinafter set forth.

- (b) Within one hundred twenty days after the effective date hereof, Southern California Freight Lines, Ltd., shall establish the service herein authorized and file in the Commission's office in triplicate tariffs satisfactory to the Commission.
- (c) The tariff filings shall be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A.
- 3. The certificate of public convenience and necessity granted in paragraph 1 of this order supersedes the certificates of public convenience and necessity authorizing Southern California Freight Lines, Ltd., to operate as a highway common carrier granted by the following decisions:

 - 2. Points on and within ten miles laterally of the following highways including points within a ten mile radius of such points:
 - a. U.S. Highway 101 between the southerly boundary of said San Francisco Territory and Los Angeles, inclusive.
 - b. U. S. Mighway 101 Alternate between El Rio and Santa Monica, inclusive.
 - c. U. S. Highway 99 between Sacramento and Los Angeles, inclusive.
 - d. Highways described in paragraph A, subparagraphs 25 through 37 of this appendix.

C. Feed, as described in Lists Los. 2, 3, 4 and 5 of Items Mos. 652, 652½ and 652-3/4, on Third Revised Page 51-B. Third Revised Page 51-C and Original Page 51-CC, respectively, of Minimum Rate Tariff Mo. 2, and farm supplies which include any article used on a farm which is consumed in the process of such use and repair parts for farm implements, machines or machinery, but does not include farm implements or complete machines:

FROM San Francisco, Oakland and San Jose, on the one hand,

TO all points on and within five miles laterally of State Highway 1 between Castroville and Carmel, inclusive, including the off-route point of Pacific Grove, on the other hand.

D. Petroleum and petroleum products, as described in Item No. 723 on Third Revised Page 58 of Minimum Rate Tariff No. 2, in metal containers, but not in bulk or in tank trucks:

Between refineries located at and in the vicinity of Richmond, Martinez and Cleum, on the one hand, and points in the Pajaro Valley Territory as defined in Appendix D attached hereto, on the other hand.

E. Empty containers:

To the points of origin of outbound movements of commodities described in paragraphs B and D above.

III. General Provisions:

Through routes and rates may be established between any and all points described in paragraphs I and II above.

Applicant may use any and all available streets and highways between the points described for operating convenience only.

Lateral and radial miles referred to in this appendix are statute miles of 5,280 feet each, measured in a straight line without regard to terrain features.

The operating authorities hereinabove set forth in paragraph II does not include the right to render service to, from or between intermediate points unless otherwise provided.

Applicant shall transport no shipments having both origin and destination within Kern County, Ventura County and/or Santa Barbara County.

Applicant shall not transport any shipments of:

- Used household goods and personal effects not packed in accordance with the crated property requirements set forth in paragraph (d) of Item No. 10-C of Minimum Rate Tariff No. 4-A.
- 2. Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine.
- 3. Articles of extraordinary value as set forth in Rule 3 of Western Classification No. 77, J. P. Hackler, Tariff Publishing Officer, on the issue date thereof.
- 4. Commodities likely to contaminate or damage other freight.

LOS ANGELES TERRITORY includes that area embraced by the following boundary: Beginning at the intersection of Sunset Boulevard and U. S. Mighway No. 101, Alternate; thence northeasterly on Sunset Boulevard to State Mighway No. 7; northerly along State Mighway No. 7 to State Mighway No. 118; northeasterly along State Mighway No. 118 through and including the City of San Fernando; continuing northeasterly and southeasterly along State Mighway No. 118 to and including the City of Pasadena; easterly along U. S. Mighway 66 to State Mighway No. 19; southerly along State Mighway No. 19 to its intersection with U. S. Mighway No. 101, Alternate, at Ximeno Street; southerly along Ximeno Street and its prolongation to the Pacific Ocean; westerly and northerly along the shore line of the Pacific Ocean to a point directly south of the intersection of Sunset Boulevard and U. S. Mighway No. 101, Alternate; thence northerly along an imaginary line to point of beginning.

APPENDIX D TO DECISION NO. 64404

PAJARO VALLEY TERRITORY includes all points on the main Pajaro Valley Highway, including Aptos, Aromas, Betabel and Watsonville, and all points on the highways diverging from said Pajaro Valley Highway from and to points located six miles laterally of the main Pajaro Valley Highway. The main Pajaro Valley Highway is from Aptos on the west via State Highway 1 through Watsonville, San Juan Watsonville Road, Aromas Road, Chittenden Pass Highway and U. S. Highway 101 to Betabel on the east.
