ORDER PERMANENTLY SUSPENDING CERTAIN SHEETS OF SCHEDULE NO. 43-T

On November 8, 1962, the Commission issued an order of investigation as above-entitled which, among other things, suspended the changes made by The Pacific Telephone and Telegraph Company in its tariffs in Schedules Cal. P.U.C. Nos. 1-T, 43-T, 89-T, 90-T, 120-T and 124-T filed by Advice Letter No. 8329 to and including March 31, 1963. Thereafter, the period of suspension was extended to and including September 30, 1963.

By Advice Letter No. 8396 filed on February 7, 1963, The Pacific Telephone and Telegraph Company requested, among other things, the permanent suspension of the changes made in Schedule No. 43-T filed by Advice Letter No. 8329.

The Commission finds that a granting of such request is not adverse to the public interest; therefore,

Company under Advice Letter No. 8329 are permanently suspended:
